We are pleased to inform you that the GBA Fintech Two-Way Internship Scheme for Post-secondary Students, Winter Term 2025/2026, sponsored by the Financial Services and the Treasury Bureau and administered by Cyberport, is now accepting applications.

This scheme offers a valuable opportunity to acquire practical work experience within the Fintech sector. Should you be interested in pursuing an internship this winter, we encourage you to submit your curriculum vitae promptly. Cyberport will facilitate internship placements with participating companies.

### **Application Period**

2025/2026 Winter-term internship will accept application starting from today to 23 February 2026.

*\*The scheme will end upon the expiry of the application period or when all the internship quotas have been placed, whichever is earlier.*

### **Eligibility**

Applicants must be:

- i. Full-time students aged 18 or above who are studying in post-secondary institutions offering financial technology-related disciplines in HK or the Mainland cities of the GBA, including higher diploma, associate degree, undergraduate, master or postgraduate students. Where an applicant's major, minor or concentration is Fintech relevant, or has studied two or more Fintech-related programmes, s/he could participate in the scheme. HKCMCL will seek participating universities to verify the applicant's qualifications or consider whether the applicant's discipline is eligible on a case-by-case basis; and
- ii. Holding a valid identity document and/or visa; and
- iii. Not receiving the HKSAR government's internship allowance from other public funding schemes; and
- iv. Is not the proprietor, director, partner, shareholder or management of the participating company for which the internship position is applied, or a relative of it; and
- v. Have not been employed by the participating company or its affiliated company for the internship position applied for within 3 months before the application period of the scheme.

Applicants could apply for internship positions in Hong Kong and Mainland cities of the Greater Bay Area as follows:

- Internship positions in Hong Kong – accept applications from Mainland students studying in HK or Mainland cities of the GBA, who hold a valid entry visa;
- Internship positions in Mainland cities of the Greater Bay Area - accepting applications from HK Students studying in HK or Mainland cities of the GBA.

### **Internship Period**

2 months, extendable to 6 months

## Internship Allowance

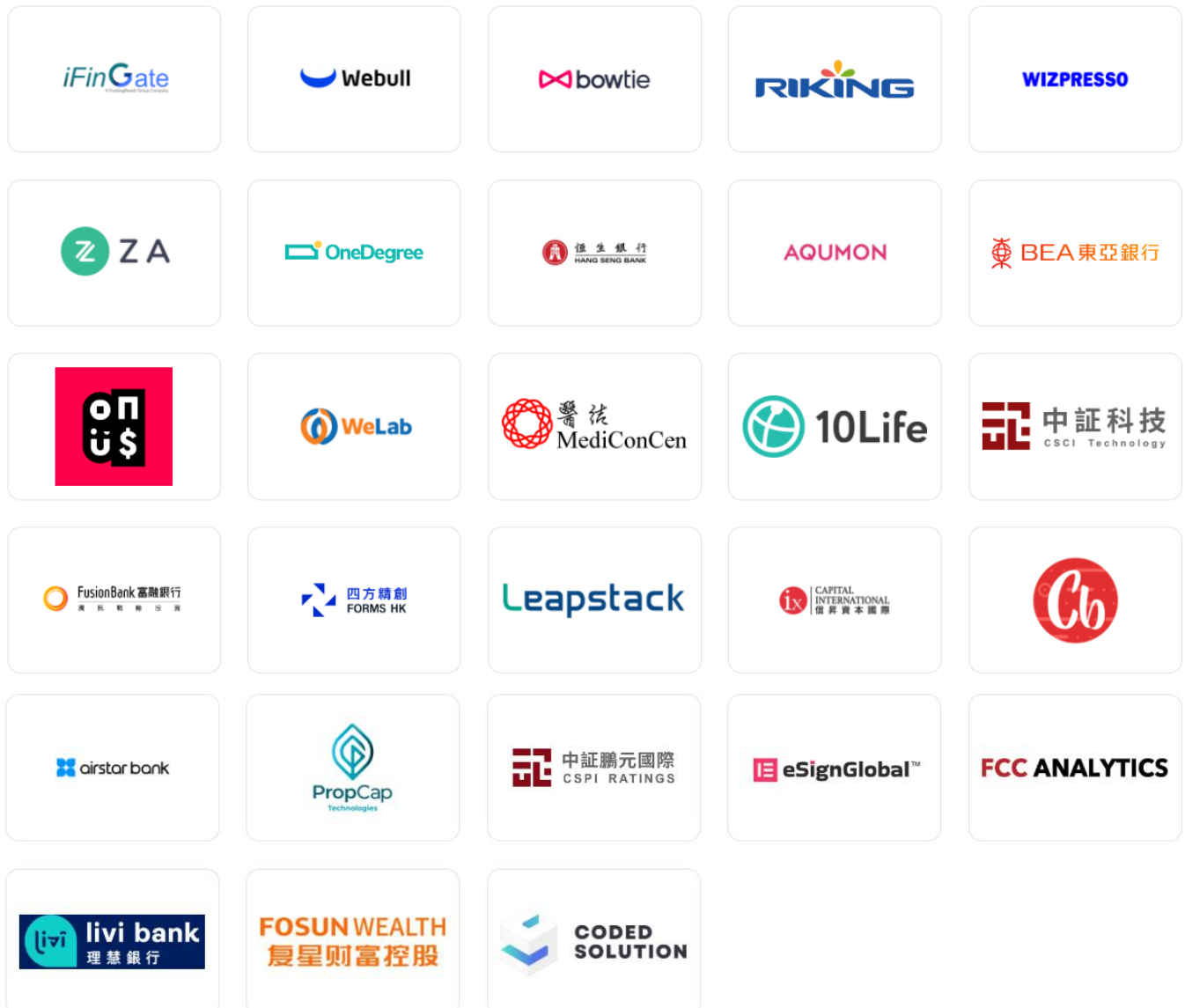
HK positions: HKD12,000 (per month)

Mainland cities in GBA positions: RMB10,500 (per month)
